

# WHITE COUNTY BOARD OF EDUCATION



Highlights of the regular board meeting on March 26, 2024, held at the White County Board of Education Office, 136 Warriors Path, Cleveland, GA, was called to order by Missy Jarrard, Chair, at 8:00 AM.

Charlie Thomas opened the meeting with prayer.

The Board approved the agenda for this morning's meeting.

The board meeting minutes for February 27, 2024, and February 29, 2024 were approved.

### **SPECIAL REPORTS**

- Lauren Anderson, Finance Director, introduced the new WCSS credit card payment system, Square. Square has been chosen as the best option for this service for its easy-to-use interface and financial security. Square will allow online payments for various WCSS events, activities, fundraisers, athletic gates, and other school uses.
- Abby Rowland, School Nutrition Director, spoke on Community Eligibility Provisions (CEP). The intent of CEP is to improve access to school meals at no cost in eligible schools with an identified student percentage of 25% or more. Eligibility for CEP is based on having an identified student percentage (ISP) of ≥ 25% as of April 1, 2024. WCSS is currently at 83%. Students will have access to one plate of two meals daily, breakfast and lunch, at no cost, reducing social stigma and improving diet for many students.

Mrs. Rowland also discussed the Georgia Ag Week Celebration. During Ag Week, students have meals made with food from local White County and Georgia farms, including Gotham Greens in Monroe, GA, Johnny Pressley Farms in Augusta, Hollands Produce in Clarksville, and Sills Milling in White County.

## **ASSISTANT SUPERINTENDENT'S REPORT**

Scott Justus presented the following:

- Construction update on the Performing Arts Center. Plan on obtaining the certificate of occupancy in April 2024.
- ESPLOST project update: WCHS Reno transition and removal of old equipment to prepare for the HS Reno has started.
- ESPLOST request: Furnishings for the new classrooms are part of the WCHS renovations. (EXHIBIT I)
- Bids and Quotes: We are currently asking for bids for Facilities Support Services and quotes for propane, natural gas, and trash collection.

#### SUPERINTENDENT'S REPORT

Dr. Laurie Burkett reported on the following:

- WCSS 2025 Academic Calendar Addendum will allow teachers more time in the classroom and also allow them to receive required training.
- ❖ Two field trip requests from WCHS, both for the JROTC.
